- Date of purchase: 17th June 2020
- The average price paid per Ordinary Share was US\$9.65 per share.

- This represents 0.01% of the issued share capital of the Company (excluding treasury shares).
- The broker used was Investec Bank plc.

Following the purchase, the total number of ordinary shares held as treasury shares is 924,694

As at the close of business on 17th June 2020, the Company had 43,793,882 ordinary shares (including treasury shares) in issue. Therefore, the total number of voting rights in the Company is 42,869,188 which may be used by shareholders as the denominator for the calculation by which they will determine if they are required to

notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
